RE:	Re-introductions of Visits & Transfer of Hospital Patients and Community Clients to Long-Term Care Homes

On behalf of the Ministry of Long-Term Care, Ministry of Health and Ontario Health we wish to express our sincere thanks and appreciation to all of you for the efforts you and your staff have made throughout the pandemic in caring for some of Ontario most vulnerable residents.

Earlier today, the Chief Medical Officer Health, Dr. David Williams, issued an updated Directive #3 under the *Health Protection and Promotion Act*. To supplement the updated Directive #3 and following consultation with operators and their associations, we are pleased today to issue updated policies that will facilitate the re-introduction of family visits for long-term care residents and enable patients currently in hospitals and the community to be admitted to long-term care where appropriate. The visitor policy will come into effect on June 18, 2020, and the revised admittance policy is effective immediately. Please refer to the attached for details on both—these are the most current policy documents.

We understand how difficult these last few months have been for everyone involved in long-term care, especially residents and families. In facilitating these changes, the government is taking a gradual approach so as to ensure the safety of resident, visitors and staff within all long-term care homes in Ontario. As we monitor the implementation of these changes, we will re-evaluate them regularly.

Thank you for your understanding of this gradual approach and for your extraordinary efforts.
